CORRECTIVE DEED

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of One and No/100 (\$1.00) and other good and valuable considerations to the undersigned, RUBY G. NOLEN, widow of William A. Nolen; RUBY G. NOLEN, as Executrix and Personal Representative of the Estate of William A. Nolen, deceased (herein referred to as "Grantor"), and RUBY G. NOLEN, as Trustee of the William A. Nolen Testamentary Trust under the Will of William A. Nolen, deceased; in hand paid by REBECCA SUE DYESS (herein referred to as "Grantee"), the receipt of which is hereby acknowledged, the said Grantor does by these presents grant, bargain, sell and convey unto the said Grantee, the following and hereinafter described parcel of real estate situated in Shelby County, Alabama, to-wit:

A parcel of land in the Southwest Quarter of the Northeast Quarter of Section 24, Township 21 South, Range 3 West, being the same land described in a deed to William A. and Geraldine Nolen, recorded in Deed Book 235 at Page 952, of the real property records of Shelby County, Alabama. Said parcel of land being more particularly described as follows:

Commencing at a rail found for the Southeast corner of said Section 24; thence N 90°00'00" W, along the South line of said Section, a distance of 1317.38 feet to the southeast corner of Southwest Quarter of the Southeast Quarter of said Section; thence N 02°56'52" W, along said Sixteenth Section, a distance of 3216.14 feet to a 3/8" rebar found, found at the point of beginning; thence N 02°56'52" W, a distance of 351.58 feet, to a 3/8" rebar found; thence N 89°38'03" W, a distance of 989.99 feet to a 1/2" rebar set, with a cap stamped "S. Wheeler RPLS 16165", on the East right-of-way of Smokey Road; thence along a curve, concave to the Southwest, in said right-of-way, having a radius of 998.29 feet and a chord bearing of S 33°19'01" E, an arc length of 415.06 feet to a 1/2" rebar set, with a cap stamped "S. Wheeler RPLS 16165"; thence S 89°02'28" E, a distance of 781.90 feet to the point of beginning, the herein described parcel contains 6.909 acres of land.
