

**AMENDMENT TO
REAL ESTATE MORTGAGE AND SECURITY AGREEMENT**

This Amendment (the "Amendment") is made and entered into on NOVEMBER 17, 2004, by and between JIMMIE PARKER CUSTOM HOMES, INC, THIS AMENDMENT IS TO ALSO CORRECT THE FORMER FILING AS LLC VS INC (hereinafter called the "Mortgagor", whether one or more) and First Commercial Bank (hereinafter called the "Mortgagee").

RECITALS

A. JIMMIE PARKER CUSTOM HOMES INC (hereinafter called the "Borrower", whether one or more) has (have) entered into as agreement entitled "First Commercial Bank Real Estate Mortgage and Security Agreement", executed by the Borrower in favor of the Mortgagee dated AUGUST 11, 2004 (the "Credit Agreement"). This Credit Agreement is in the amount of ONE HUNDRED SEVENTY TWO THOUSAND FIVE HUNDRED DOLLARS AND NO/100 Dollars (\$172,500.00).

B. The Mortgagor has executed in favor of the Mortgagee a Real Estate Mortgage and Security Agreement (the "Mortgage") recorded SEPTEMBER 7, 2004 in Inst.# 20040907000497630, in the Probate Office of SHELBY County, Alabama.


