Know All Men by These Presents: That in consideration of **One hundred sixty seven thousand nine hundred and no/100 (\$167,900.00)** to the undersigned grantor, a corporation, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **J. Subject to existing easements, restrictions, set-back lines, right of way, limitations, if any of record.

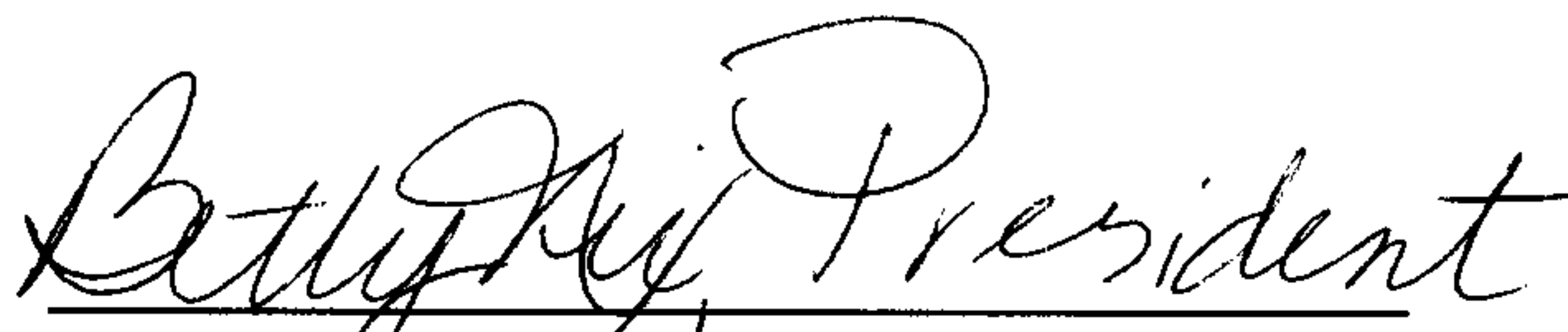

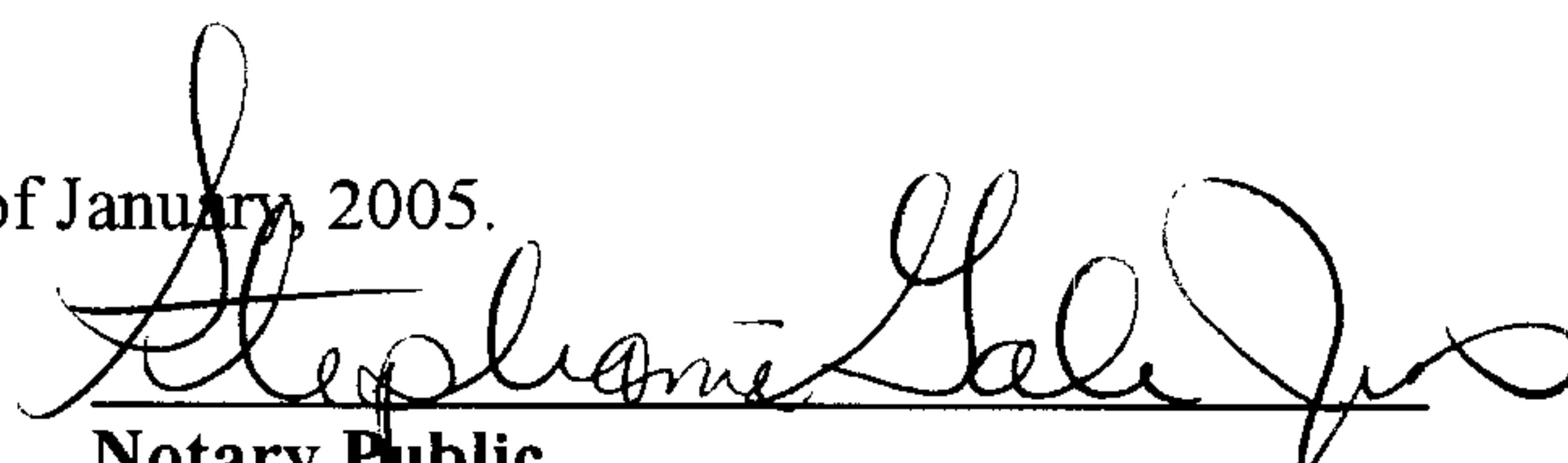
