Subject to taxes for 2004 and subsequent years, easements, restrictions, rights of way and permits of record.

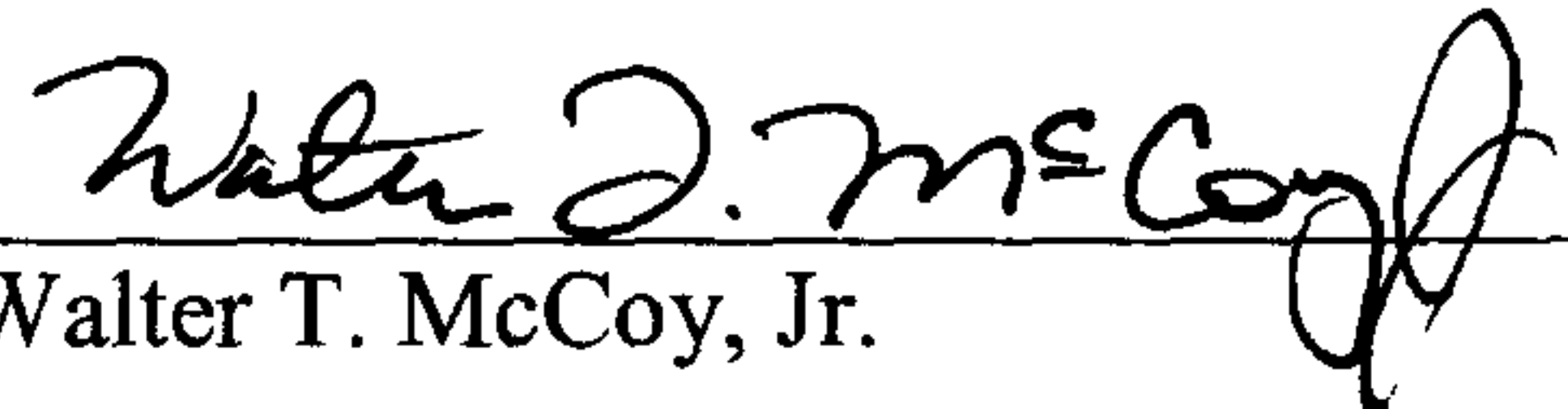
\$ 126,000.00 of the above recited purchase price was paid from a mortgage recorded simultaneously herewith.

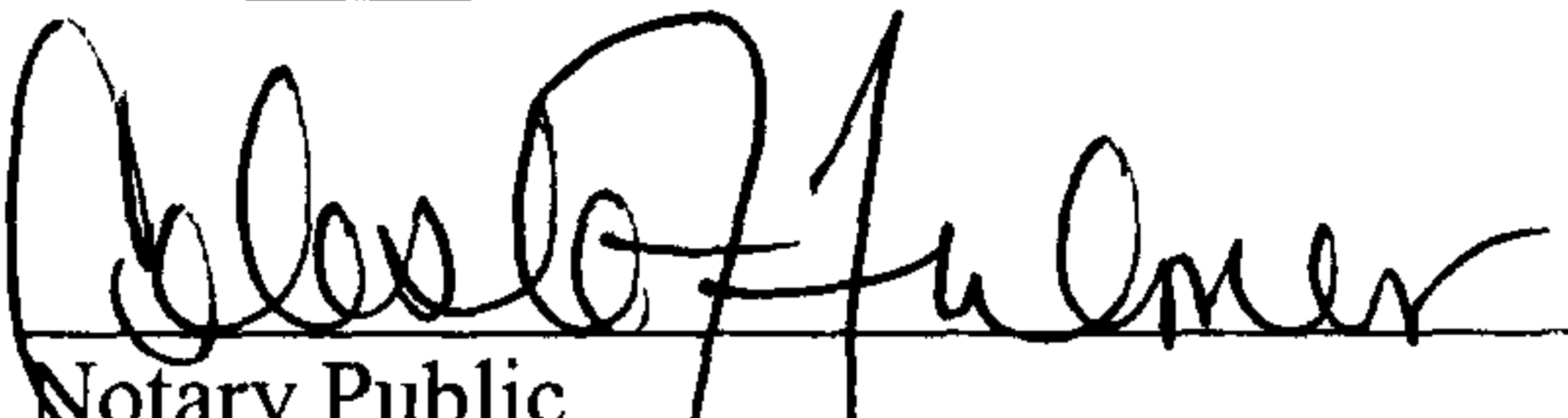

A parcel of land in the Northwest Quarter of Section 25, Township 21 South, Range 1 West, Shelby County, Alabama, described as follows: Commence at the Northwest corner of said Section 25; thence run South along the West section line 1573.22 feet; thence turn left 103 degrees 26 minutes 48 seconds a distance of 576.78 feet; thence turn left 15 degrees 09 minutes 33 seconds a distance of 834.70 feet to a point on the North right-of-way of Alabama Highway 25 and the southeast corner of Shelby County Board of Education (formerly Columbiana Elementary School); thence turn left 05 degrees 16 minutes 00 seconds a distance of 63.21 feet; thence turn left 02 degrees 12 minutes 00 seconds a distance of 103.53 feet to a right-of-way monument; thence turn left 02 degrees 44 minutes 00 seconds a distance of 27.85 feet along said right-of-way to the point of beginning; thence turn left 85 degrees 29 minutes 40 seconds and run North 43 degrees 35 minutes 03 seconds West a distance of 131.75 feet to an iron; thence run North 41 degrees 59 minutes 09 seconds West a distance of 79.88 feet to an iron; thence run North 41 degrees 54 minutes 12 seconds West a distance of 117.90 feet to an iron; thence run North 50 degrees 53 minutes 57 seconds East a distance of 146.58 feet to an iron on the West right-of-way of Goodwin Street; thence run South 44 degrees 34 minutes 21 seconds East a distance of 305.80 feet along said Goodwin Street to an iron on the North right-of-way of East College Street (Old Highway #25); thence run South 41 degrees 57 minutes 45 seconds West a distance of 157.56 feet along said College Street to the point of beginning.
