To incorporate, file the original and two copies of the Articles of Incorporation in the county where the corporation's registered office is located. The Secretary of State's filing fee is \$20. Please contact Judge of Probate to verify filing fees. Step 2: Non-profit corporations MUST have at least three directors.

Pursuant to the provisions of the Alabama Non-Profit Corporation Act, the undersigned hereby adopts the following Articles of Incorporation.
