

The undersigned, acting organizer of Home and Property Services, L.L.C. (L.L.C.), a limited liability company organized pursuant the Alabama Limited Liability Company Act, hereby adopt the following Articles of Organization for the L.L.C.

1. The name of the LLC is "Home and Property Services, L.L.C."
2. The complete address of the LLC's initial registered office in Alabama is: **BESS M. SPEEGLE**

4. At the time of the filing of these Articles, there are two (2) members of the LLC.
5. The purpose of the LLC is to perform: residential design and construction; professional engineering; and investing.
6. Initial Contribution- The members initially shall contribute to the Company capital as described in Attachment "Listing of Capital Contributions".
7. The liability of the Members shall be limited as provided under the laws of Alabama Limited Liability statutes. Members that are not Managers shall take no part whatever in the control, management, and direction of the company. Member can obligate the Company for engineering services and materials. The L.L.C. will be managed by the Owner/Organizer/Manager.
8. The duration of the LLC is 35 years.
9. This LLC shall not be dissolved and shall not be required to be wound up by reason of any event that terminates the continued membership of a member is at least (1) remaining member and the existing and business of the LLC is continued by the consent of the manager.
10. The manager shall have the right to add additional members. Any member who is subsequently admitted as a member of the Company shall have all rights and obligations of a member under the "Limited Liability Company Agreement."
11. A member may be expelled at any time by consent of the manager at the time of such expulsion, inclusive of the voting power of the member whose expulsion is sought.
12. The company shall be managed by one Owner/Organizer/Manager. The initial manager is Bess M. Speegle. The powers of the manager include: the sale, development lease of other disposition of the Company's assets; the purchase and other acquisition of other assets of any kinds, and the borrowing of money; the prepayment, refinancing or extension of any loan affecting the company's assets. The manager shall determine and distribute funds when he wants to.
