## KNOW ALL MEN BY THESE PRESENTS, THAT

WHEREAS, the undersigned Frank C. Ellis, III, LLC, an Alabama limited liability company, and S.K. Properties, LLC, an Alabama limited liability company, are justly indebted to Donald H. Myers and wife, Barbara E. Myers in the sum of Seventy Five Thousand One Hundred and NO/100 Dollars (\$75,100.00) (the "Indebtedness") evidenced by a promissory note of even date, and

WHEREAS, it is desired by the undersigned to secure the prompt payment of the Indebtedness with interest.
