**MORTGAGE FORECLOSURE DEED**

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on September 24, 1998, **Brandon Jeffrey Brunson**, a single person, Party of the First Part, executed a certain mortgage to **Old Kent Mortgage Company**, which said mortgage is recorded in Instrument No. 1998-39164, in the Office of the Judge of Probate of Shelby County, Alabama. Which said Mortgage was last sold, assigned and transferred to Nationsbanc Mortgage Corporation, Party of the Second Part; and

WHEREAS, default in the payment of the indebtedness secured by said mortgage, and Bank of America N.A., successor by merger with Nationsbanc Mortgage Corporation did declare all of the indebtedness secured by the said mortgage due and payable and said mortgage subject to foreclosure as therein provided and did give due and proper notice of the foreclosure of said mortgage, in accordance with the terms thereof, by publication in the Shelby County Reporter, a newspaper of general circulation in Shelby County, Alabama, in its issues of 12/29/04, 01/05/05, 01/12/05; and

WHEREAS, on January 20, 2005, the day on which the foreclosure sale was due to be held under the terms of said notice, during the legal hours of sale, said foreclosure was duly and properly conducted and the person conducting the sale on behalf of the mortgagee did offer for sale and sell a public outcry, in front of the main entrance of the Courthouse, Shelby County, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid obtained for the property described in the aforementioned mortgage was the bid of Shelby Resources, Inc. in the amount of **SEVENTY-FIVE THOUSAND TWO HUNDRED SEVENTY-FIVE AND 00/100 DOLLARS (\$75,275.00)**; which the person conducting the sale on behalf of the mortgagee offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to Shelby Resources, Inc.; and

WHEREAS, **Karan G. Greer**, conducted said sale and acted as auctioneer thereat, under and pursuant to an appointment as such by the Party of the Second Part; and

WHEREAS, said mortgage expressly authorized the mortgagee or auctioneer or any person conducting said sale to execute to the purchaser at said sale a deed to the property so purchased.

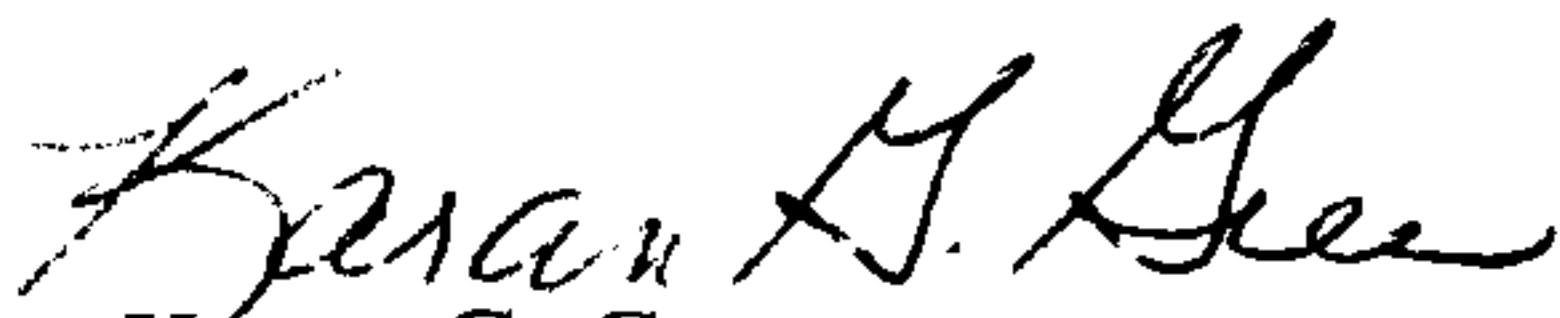

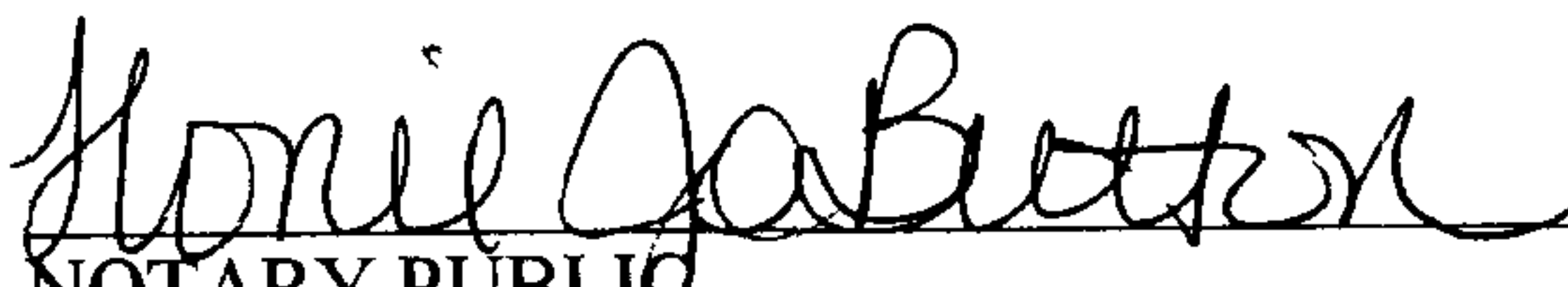
