

## MORTGAGE MODIFICATION AGREEMENT

THESE THINGS CONSIDERED, Mortgagee hereby allows Mortgagor to increase the original mortgage from ONE HUNDRED EIGHTY EIGHT THOUSAND EIGHT HUNDRED, and 00/100 Dollars (\$188,800.00) to TWO HUNDRED THIRTEEN THOUSAND EIGHT HUNDRED, and 00/100 Dollars (\$213,800.00). The new note shall be secured by the original above described mortgage as modified and amended herein and amortized under the terms and conditions of the new note executed simultaneously with this agreement.
