

NOW THEREFORE, in consideration of the sum of One Dollar in hand paid each of the parties hereto to the other, the receipt hereof is hereby acknowledged and of other good and valuable consideration, and in order to induce **MARIA WILLIAMS AND MITCHELL WILLIAMS, WIFE AND HUSBAND** to make the said loan and to subordinate the said mortgage of First Federal Bank, it is mutually agreed as follows:

1. That First Federal Bank consents to and with **MARIA WILLIAMS AND MITCHELL WILLIAMS, WIFE AND HUSBAND**, that the lien of it's mortgage as hereinabove referenced, is now, and shall continue to be subject and subordinate to the lien of the mortgage made to **FIRST FEDERAL BANK** in the amount of **\$116,000.00** dated the **29<sup>TH</sup>** day of **October 2004** and recorded in the Probate Office of **SHELBY** County, Alabama, in **Instrument Number 20041110000620510**.
2. That this Agreement shall be binding upon and secure the parties hereto and their respective heirs, legal representatives, successors and assigns, and shall inure to the benefit of **FIRST FEDERAL BANK**, it's successors and assigns.


