Know All Men by These Presents: That in consideration of **One hundred forty three thousand nine hundred and no/100 (\$143,900.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Laura Y. Reynolds f/k/a Laura Y. Schmid and Charles Reynolds, wife and husband and Dan M. Youngblood, a married man** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Christopher Emery and Doree Emery and Francie Emery and Richard Emery** (herein referred to as grantee, whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:
