WARRANTY DEED, JOINILY FOR LIFE WITH REMAINDER TO SURVIVOR

STATE OF ALABAMA SHELBY COUNTY

KNOW ALL MEN BY THESE PRESENTS,

That in consideration of ONE HINDRED THIRTY NINE THOUSAND & NO/100—(\$139,000.00) DOLLARS to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, Mary Joan Johnson, a single individual (herein referred to as grantors), do grant, bargain, sell and convey unto J. Vichael Fleming and wife, Lynn M. Fleming (herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 26, in Block 3, according to the Survey of Norwick Forest, First Sector, as recorded in Map Book 11, page 63, in the Probate Office of Shelby County, Alabama. Mineral and mining rights excepted.
