Exhibit A to UCC Financing Statement from Montevallo Foods, L.L.C. ("Debtor") to The Peoples Bank and Trust Company ("Secured Party")

All of the following property of Debtor, whether now owned or hereafter acquired or arising, wherever located, to-wit:

- A. <u>Deposit Collateral</u>. All property of Debtor left with Secured Party or in its possession now or hereafter, all deposit accounts of Debtor now or hereafter opened with Secured Party, all certificates of deposit issued by Secured Party to Debtor, and all drafts, checks and other items deposited in or with Secured Party by Debtor for collection now or hereafter.
- B. <u>Equipment Collateral</u>. All general intangibles of every nature of Debtor, whether now existing or hereafter acquired or arising, including, without limitation all: claims; contracts and contract rights; actions or causes of action; goodwill; and books and records in whatever media recorded or stored.
- D. Lease Collateral. All right, title, and interest of said Debtor as Lessee of the Store known as Lucky's Foodland located at 4000 Alabama Highway 25, Montevallo, Alabama.
- E. <u>Proceeds</u>. All products and/or proceeds of any and all of the foregoing, including, without limitation, insurance or condemnation proceeds, all property received wholly or partly in trade or exchange for any of the foregoing, and all rents, revenues, issues, profits and proceeds arising from the sale, lease, license, encumbrance, collection or any other temporary or permanent disposition of any of the foregoing or any interest therein.
