That in consideration of **TWO HUNDRED THIRTY FIVE THOUSAND FIVE HUNDRED EIGHTY TWO AND NO/00 (\$235,582.00)**, and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we,

(herein referred to as grantor) grant, bargain, sell and convey unto,

JOHN O STRANGE AND CYNTHIA V STRANGE

(herein referred to as grantees), the following described real estate, situated in: SHELBY County, Alabama, to-wit:
