

Commence at the SW corner of the NW¼ of the SE¼ of Section 22 Township 21 South, Range 1 East, thence run Easterly along the south line thereof for 83.74 feet; thence 90 degrees 51 minutes 26 seconds left run Northerly 110.86 feet; thence 88 degrees 53 minutes left run Westerly 940.15 feet; thence 91 degrees 06 minutes 30 seconds left run Southerly 110.86 feet; thence 87 degrees 54 minutes 20 seconds left run Easterly 194.62 feet to a point on the south line of the NE ¼ of the SW ¼ of said section; thence 1 degree 14 minutes 42 seconds left run Easterly along said ¼-¼ line 661.84 feet to the Point of Beginning. Containing 2.43 Acres.
