ORDER OF COURT

This cause coming on to be heard on the 13th day of December, 2004, after proper notice to the parties, for the express purpose of receiving the testimony, survey and report of the court-appointed surveyor, Sid Wheeler, and the Court having called this matter for hearing, and the said surveyor, Sid Wheeler, appearing and presenting testimony with regard to said surveyed boundary line, and presenting his judicial survey of the boundary line separating the property of the plaintiffs and defendant Annette Tyler Pearson from the property of the other defendants, and upon consideration thereof, it is, therefore, ORDERED, ADJUDGED and DECREED as follows:

- 1. That the Court readopts and reaffirms its Order of Court dated September 30, 2003, and entered by the Clerk on October 2, 2003.
- 2. That the boundary line separating the property of the plaintiffs, Robert Woodson, Flora Lee Lacey, Henry Lee Woodson, Marilyn Roberta Allen, Shirley Ann Lily, Carolyn Annette Washington, and Linda Marie Herndon, and defendant, Annette Tyler Pearson, from the property owned by the defendants, Christine L. Jemison, Fred Lacey, Tracy Lacey, Larry Lacey, Darlene Townsend, Willie Lacey, Tyler Fairbanks, and Tim Fairbanks, is more particularly described as follows:

A boundary line in the NW 1/4 of the SE 1/4 of Section 5, Township 24 North, Range 13 West, being more particularly described as follows:

Beginning at a one and one-half inch (1 %") pipe, found at the Northeast corner of said Section 5; thence South 30 deg. 39' 12" West, a distance of 3122.27 feet to a onehalf inch (光") rebar set, with a cap stamped "S.Wheeler CA 0502", being on the South right-of-way of Shelby County Highway 227 South, and being the North end of said boundary line, and the point of beginning hereof; thence South 31 deg. 50' 53" West, to the boundary line of Chemical Lime Company, a distance of 250.34 feet, more or less, to a one-half inch (%") rebar set, with a cap stamped "S.Wheeler CA 0502", and being the South end of said boundary line. (In order to tie into the established and recognized Southeast section corner from the South end of the measured boundary line described herein, and purely for informational and reference purposes, thence South 41 deg. 31' 48" East, a distance of 3129.50 feet, to a two inch (2") pipe, found at the Southeast corner of said Section 5). According to survey and report of Sid Wheeler, Registered Professional Land Surveyor No. 16165.

3. That costs of Court are taxed as paid.
