## CERTIFICATE OF TRUST

WHEREAS, SHERRY F. BASS (hereinafter referred to as Guentor), and SHERRY F. BASS, as Trustee, entered into a certain Trust Agreement known as the SHERRY F. BASS REVOCABLE TRUST on the 17th day of December, 1999; and

- 3. To sell or dispose of or grant options to purchase any property, real or personal, constituting a part of the Trust Estate.
- 4. To hold any securities or other property in the Trustee's own name or in the name of a nomines (with or without disclosure of any fiduciary relationship) in bearer form.
- 5. To refrain from voting or to vote shares of stock owned by the Trust Exate at stockholders' meetings in person or by special, limited, or general proxy and in
