**ARTICLES OF ORGANIZATION OF**

Jason Buckner hereby forms this limited liability company pursuant to Title 10-12-1 et seq. of the Code of Alabama as last amended (hereinafter "the Act").

1. **Name.** The name of this limited liability company shall be hugeletters.com, LLC, which, shall hereinafter be referred to as the "Company".
2. **Purpose.** The purposes for which this Company is formed are as follows:
  - (a) To create and purchase products from various vendors for resale live and over the internet, as well as to engage in the transaction of any other lawful business permitted under the laws of the State of Alabama;
  - (b) To enter into, perform and carry out contracts and agreements necessary, appropriate or incidental to the accomplishment of the purposes of the Company; and
  - (c) To do any other acts and things which may be necessary, appropriate or incidental to the carrying out of the business and purposes of the Company, subject to the terms and conditions of this Operating Agreement.
3. **Location.** The location of the initial registered office of the Company shall be 6152 Eagle Point Circle, Birmingham, AL 35242. The name of the initial registered agent of the company shall be Jason D. Buckner, 6152 Eagle Point Circle, Birmingham, AL 35242.
4. **Duration.** This company shall have a perpetual duration except as otherwise provided in the Company's Operating Agreement executed contemporaneously herewith.
