WARRANTY DEED

Know All Men by These Presents: That in consideration of ONE HUNDRED TWENTY FOUR THOUSAND NINE HUNDRED FIFTY AND NO/100 DOLLARS (\$124,950.00) to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, THE LORRIN GOUP, LLC (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto CHARLES ADAMS (herein referred to as grantees, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 10, in the Meadows at Meriweather, Phase 1, as recorded in Map Book 33, Page 69, in the Probate Office of Shelby County, Alabama.

Subject to:

- 1) Rights or claims of parties in possession not shown by the public records.
- 2) Easements or claims thereof, which are not shown by the public records.
- Discrepancies, conflicts in boundary lines, shortage in area, encroachment, and any facts which a correct survey and inspection of the premises would disclose and which are not shown by the public records.
- Any lien, or right to a lien, for services, labor or material imposed by law and not shown by the public records.

- 10) Restrictions in favor of Alabama Power Company regarding underground utilities as setforth in Instrument # 20040629000354890 and in Instrument #20040910000506050.
- Title to all oil, gas and minerals within and underlying the premises, together with all oil and mining rights and other rights, privileges and immunities relating thereto, together with any release of liability for injury or damage to persons or property as a result of the exercise of such rights
