**WARRANTY DEED**

Know All Men by These Presents: That in consideration of **ONE HUNDRED TWENTY FOUR THOUSAND NINE HUNDRED FIFTY AND NO/100 DOLLARS (\$124,950.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **THE LORRIN GOUP, LLC** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **CHARLES ADAMS** (herein referred to as grantees, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 10, in the Meadows at Meriweather, Phase 1, as recorded in Map Book 33, Page 69, in the Probate Office of Shelby County, Alabama.

Subject to:

- 1) Rights or claims of parties in possession not shown by the public records.

SUBJECT TO easements, reservations, restrictions and covenants, set back lines and rights of way, if any, of record.

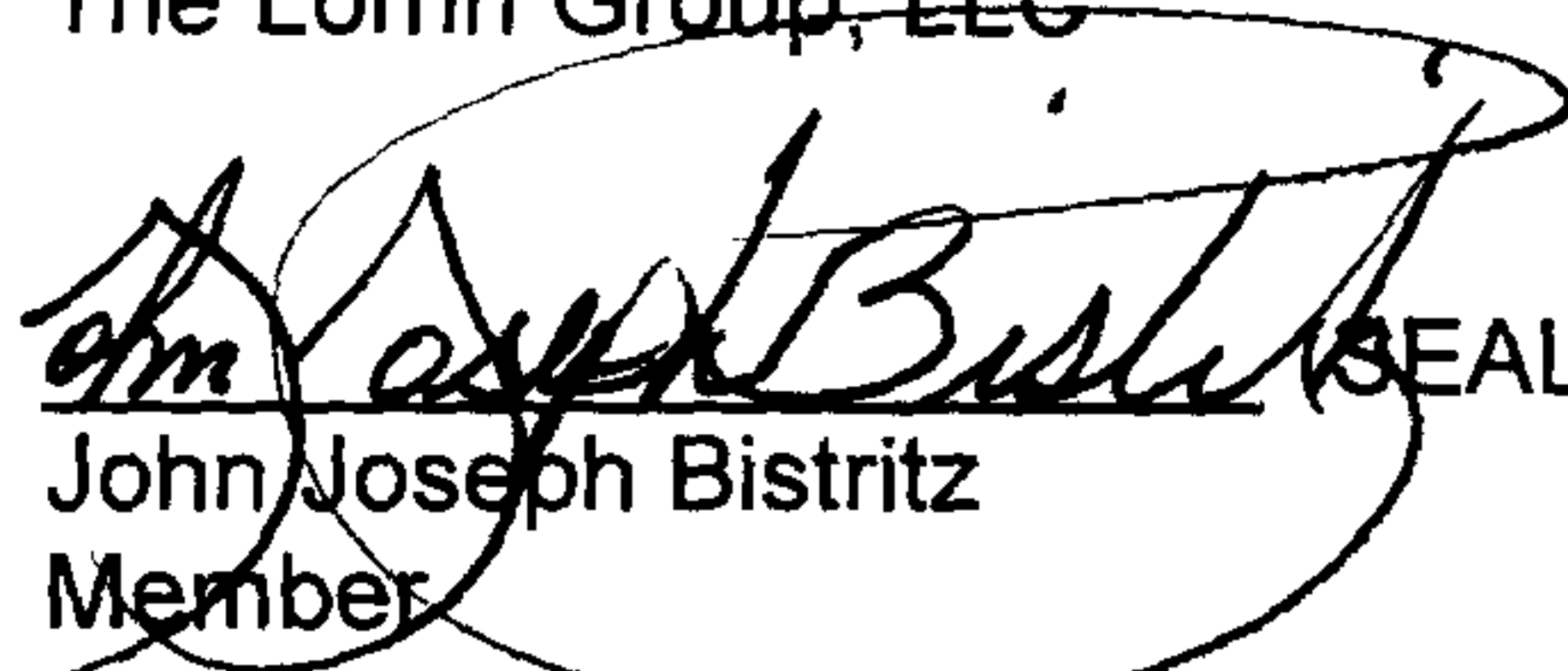
\$112,450.00 of the purchase price recited above was paid from mortgage loan closed simultaneously herewith.

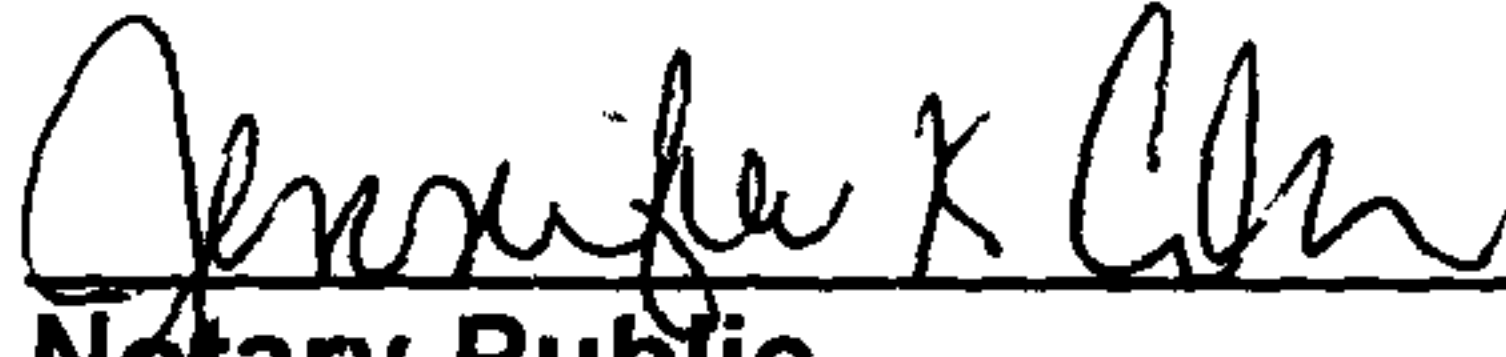
