KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, to the undersigned Grantor, Wachovia Bank, National Association, d/b/a SouthTrust Bank, as Personal Representative of the Estate of William S. Mitchell, deceased, (hereinafter referred to as the "Decedent"), who died on and whose Will is probated as Case No. 185049 in the Probate Court of Jefferson County, State of Alabama, in hand paid by Shane Schroeder, (hereinafter referred to as "Grantee"), the receipt whereof is hereby acknowledged, the said Wachovia Bank, National Association, d/b/a SouthTrust Bank, as Personal Representative of the Estate of William S. Commence at the northwest corner of the South Half of the East Half of the SE ¼, Section 22, Township 22 South, Range 2 West, according to a survey by F. W. Wheeler (Sept. 5, 1968); thence proceed North 88 deg. 40 min. East (magnetic bearing) for a distance of 115.00 feet to a point being on the east right of way line of Countryclub Drive; thence turn 90 deg. 36 min. 45 sec. to the left and run 615.00 feet along said right of way to the point of beginning of the parcel of land herein conveyed; thence continue along said right of way for a distance of 205.00 feet to a point; thence turn 90 deg. 36 min. 45 sec. to the right and run 221.67 feet to a point; thence turn 90 deg. 18 min. 23 sec. to the right and run 205.00 feet to a point; thence turn 90 deg. 18 min. 23 sec. to the right and run 220.57 feet to the point of beginning; Said property is situated in the SE1/4 of Section 22, Township 22 South, Range 2 West, and contains 1.04.
