**PARTIAL SATISFACTION AND RELEASE**

The undersigned, St. Vincent's Hospital, Judgment Lien Holder, by Certificate of Judgment recorded in Book 2003, Page 0905000590410, of the records of the Office of the Judge of Probate, Shelby County, Alabama, does hereby release the following described property from the lien of said Judgment:

A parcel of land in the SE  $\frac{1}{4}$  of NW  $\frac{1}{4}$ , Section 26, Township 20 South, Range 1 West, Shelby County, Alabama, described as follows: From the NW corner of the SE  $\frac{1}{4}$  of the NW  $\frac{1}{4}$  of Section 26, Township 20 South Range, 1 West, run thence South along the West boundary of said SE  $\frac{1}{4}$  of NW  $\frac{1}{4}$  a distance of 373.54 feet to the point beginning of herein described lot; thence continue along said course a distance of 259.10 feet; thence turn 104 deg. 16 min. 24 sec. left and run 222.91 feet; thence turn 82 deg. 09 min. 01 sec. left and run 183.25 feet; thence turn 77 deg. 08 min. 31 sec. left and run 196.76 feet to the point of beginning of herein described lot; being situated in Shelby county, Alabama.

Also, a 20.0 foot easement for ingress and egress described as follows: From the NE corner of aforesaid lot, run west along the North boundary of said lot a distance of 30.90 feet to the point of beginning of the centerline of herein described 20.0 foot easement; thence turn 92 deg. 24 min. 41 sec. right and run 246.14 feet along said easement centerline to appoint of termination in the center of Joseph Drive.


