THAT IN CONSIDERATION OF **Two Hundred Sixty Nine Thousand One Hundred and 00/100** (\$269,100.00) **Dollars** and other good and valuable consideration to the undersigned Grantor in hand paid by the Grantee herein, the receipt of which is hereby acknowledged, **Midnight Properties, LLC, a limited liability company,** (herein referred to as Grantor) does grant, bargain, sell and convey unto **Stonecrest Development, LLC., a limited liability company,** (herein referred to as Grantee), the following described real estate, situated in the State of Alabama, County of Jefferson, to-wit:

Lots 69, 73, 75, 113, 119, 120, 178, 180 and 182, according to the Map of Heritage Trace, Phase I, Sector I as recorded in Map Book 34, Page 114, in the Probate Office of Shelby County, Alabama.


- (A) Subject to Declaration of Protective Covenants for Heritage Trace as recorded in Instrument No. 20050307000105180.

- (D) And also subject to existing easements, restrictions, current taxes, set-back lines, rights of way, limitations, if any, of record.

By acceptance of this warranty deed, Grantee hereby covenants and agrees for itself and its successors, assigns, licensees, employees and agents that Grantor shall not be liable for and no action shall be asserted against Grantor for, loss or damage on account of injuries to the Property or to any buildings, improvements or structures now or hereafter or located upon the Property or on account of injuries to any owner, occupant, or other person in or upon said property, which are caused by or arise as a result of, past or future soil and/or subsurface conditions, known or unknown, (including without limitations, sinkholes, underground mines and limestone formations) under or on the property or any property now or thereafter owned by Grantor whether contiguous or noncontiguous to the Property. For purposes of this paragraph the term Grantor shall mean and refer to (i) the partners, agents and employees of Grantor (ii) the officers, directors, employees and agents of the Grantor and (iii) any successors and assigns of the Grantor's interest in the Property. This covenant and agreement shall run with the land conveyed hereby as against Grantee, and all persons, firms, trusts, partnerships, limited partnerships, corporations, or other entities holding under or through the Grantee.

NOTE: This is not the homestead of the Grantor or the Grantee.

NOTE: All of the above consideration was derived from the proceeds of a mortgage loan closed simultaneously herewith.
