

FRANKS (herein referred to as grantees, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 5, in the Meadows at Meriweather, Phase 1, as recorded in Map Book 33, page 69, in the Probate Office of Shelby County, Alabama.


Subject to:
