ARTICLES OF ORGANIZATION
OF
ANCO HOMES, L.L.C.

Pursuant to the Provisions of Act No. 93-724 of the 1993 Alabama Legislature or the Alabama Limited Liability Company Act ("Act"), the undersigned hereby adopt the following Limited Liability Company Articles of Organization:

ARTICLE I
Name

The name of the limited liability company ("Company") is ANCO HOMES, L.L.C.

ARTICLE II
Duration

The Company shall be dissolved, and its affairs wound up, upon the occurrence of the first of the following events:

- (i) the unanimous written consent of the Members to dissolve the Company;
- (ii) an event of dissociation of a member pursuant to Section 10-12-36 of the Act, unless there are at least two Remaining Members (or at least one Remaining Member and a new Member is admitted) and the legal existence and business of the Company is continued by unanimous consent of the Remaining Members within ninety (90) days thereafter;
- (iii) when the Company is not the successor in a merger or consolidation of the Company with one or more entities; or
- (iv) upon the entry of a decree of judicial dissolution pursuant to Section 10-12-38 of the Act.

ARTICLE III

The purposes for which the Company is formed are as follows:

- (a) To engage in the operation and management of a homebuilding business.
- (b) To engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Act.

ARTICLE IV
Registered Agent and Office

The address of the Company's initial registered office in Alabama is 1014 River Highlands Circle, Birmingham, Alabama 35244. The name of Company's initial registered agent at that address is Thomas C. Anderson.

ARTICLE V
Initial Members

The names and addresses of the Company's initial members are:

ARTICLE VI
Management

The Company is to be managed by its members.

ARTICLE VII
Admission of New Members

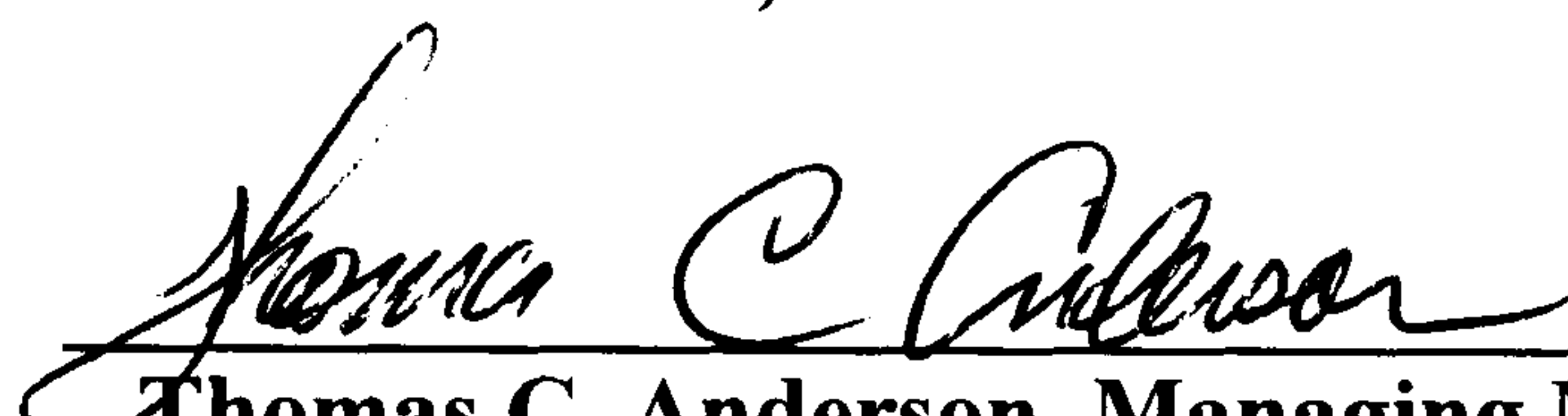

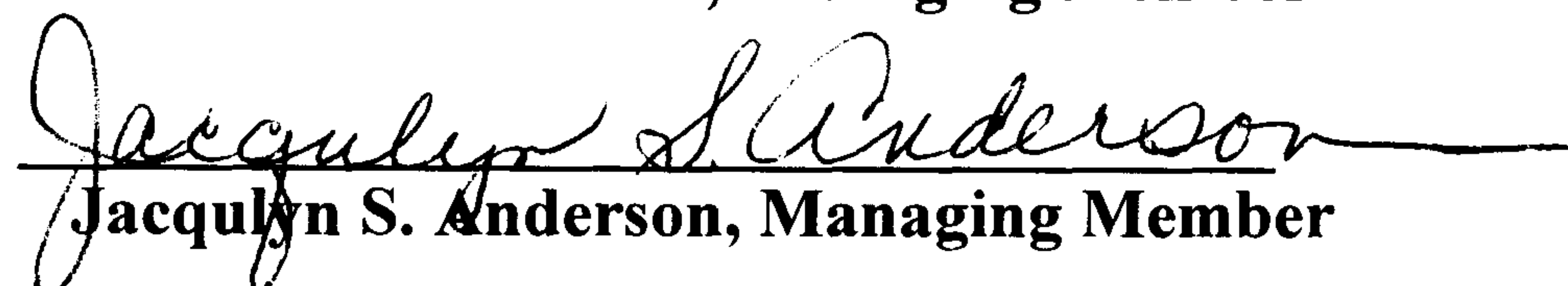
ARTICLE VIII
