

Articles Of Incorporation

JBF Sales, Inc.

Pursuant to Alabama Code 1975, as amended, Section 10-2B-2.02, the following Articles of Incorporation are set out:

- I. **NAME:** The name of the corporation is JBF Sales, Inc.
- II. **AUTHORIZED SHARES:** The Corporation is authorized to issue One Thousand (1,000) shares of common stock. There shall only be one class of stock.
- III. **REGISTERED AGENT AND REGISTERED OFFICE:** The street address of the corporation's initial registered office is 733 Windsor Court, Alabaster, Alabama, 35007 and the name of the initial registered agent at such office is Jameson Barrett Falls.
- IV. **INCORPORATOR:** The incorporator for the corporation is Jameson Barrett Falls whose address is 733 Windsor Court, Alabaster Alabama 35007.
- V. **DIRECTORS:** The corporations shall not operate with less than one director. The name and address for the individual who is to serve as the initial director is as follows:

 (a) Jameson Barrett Falls, 733 Windsor Court, Alabaster, Alabama 35007
- VI. **PURPOSE:** The purpose for which the corporations is organized, is to transact any and all lawful business for which corporations may be incorporated under Alabama Code 1975 Section 10-2B-1.01 et seq.
- VII. **LIMITATION OF LIABILITY:** No director of shareholders of the corporation shall be liable to the corporation for money damages for any action taken, or any failure to take any action, as a director or as a shareholder except liability for (i) the amount of a financial benefit received by a director or shareholder to which he or she is not entitled; (ii) and intentional infliction of harm on the corporation; (iii) a violation of Alabama Code 1975 Section 10-2B-8.33; and (iv) and intentional

violation of criminal law; or (v) a breach of the directors duty of loyalty
to the corporation of its shareholders.
