AFFIDAVIT OF HARVEY S. JACKSON, JR.

RE: GENEALOGY OF THE HEIRS OF DELLA M. BROWN, DECEASED

Before me, a notary public, state at large, personally appeared, Harvey S. Jackson, Jr., who being by me first duly sworn doth depose on his oath and says as follows:

My name is Harvey S. Jackson, Jr. I am 82 years of age, my address is P. O. Box 611, Jasper, Alabama, 35502. I have been engaged in the active practice of law in Jasper, Alabama for more than 50 years, next preceding the day hereof. The information furnished herein is based on my personal knowledge.

The purpose of this affidavit is to provide genealogy information of the heirs and descendants of Della M. Brown, deceased to the lot described as follows:

A part of that certain lot in the town of Montevallo sometimes called "Lot No. 55" heretofore known as and called "The Vandegrift Home Lot" and which lies opposite to and across North Boundary Street from Lot No. 29, according to the "Original Plan" of said town, as recorded in the Office of the Probate Judge of said Shelby County, and which part of said lot hereby conveyed is more particularly described as follows, to-wit: Beginning at the Eastern most intersection of North Boundary Street (sometimes called "Walnut Street") with Valley Street according to said "Original Plat or Plan"; running thence Northeast along Valley Street 75 feet, more or less, to the line of what has heretofore been known as and called "The E.G. Walker Lot"; thence Southeasterly along the line of said Walker Lot and parallel with said North Boundary Street a distance of 150 feet; thence Southwest parallel with Valley Street a distance of 75 feet, more or less, to the Northeast line of said North Boundary Street and thence Northwest along said last mentioned line 150 feet, to said point of beginning.

Less and except that portion conveyed to Alabama Coach Company, Inc., by deed recorded in Deed Book 120, Page 538, in Probate Office.

The genealogy information is as follows:



1. Della M. Brown, deceased, had five children. They are as follows:
 - a) Lillian Brown Jackson, a daughter, died on August 17, 1977, leaving children set out below.
 - b) Crawford Allen Brown, a son, died on November 2, 1966. He had no children.
 - c) Willie Mae Brown Ambrose, a daughter, died in early 1980's. She had no children. Her husband Oliver predeceased her.
 - d) Jadie Hansel Brown, a son, deceased, leaving children set out below.
 - e) Wyman W. Brown, a son, deceased, leaving James A. Brown, a son, and William B. Brown, a resident of the State of Virginia.
2. Della M. Brown, deceased, died on November 29, 1966, leaving a Last Will and Testament, probated in the Probate Court of Shelby County, Alabama. Letters Testamentary were issued on or about December 16, 1966.
3. At the time of Della's death she owned the subject lot. She devised the lot under her will to three of her children, Lillian Brown Jackson, my mother, Jadie Hansel Brown, and Wyman W. Brown in equal shares, or 1/3 to each of them.
4. Lillian Brown Jackson let a Will which was probated in the Probate Court of Walker County, Alabama and Letters Testamentary issued on September 7, 1977. Her estate has long since been closed out. Her will devised her 1/3 interest to her only children, myself, Harvey S. Jackson, Jr., and Benjamin Brown Jackson, my brother, in equal shares, or a 1/6 interest to each of us.
5. Benjamin Brown Jackson is deceased, having died on or about the year 1974, leaving surviving him a widow and four children as follows:
 - a) Widow, Mary Alice Jackson, approximately 75 years of age, P.O. Box 98, Anadarko, OK 73005, single.
 - b) Son, Benjamin Brown Jackson, age 49, 1100 Shaw Drive, Ada, OK 74820, married.

- d) Daughter, Suzanne S. Jackson, age 40, P.O. Box 98 Anadarko, OK 73005, single.


6. Jadie Hansel Brown, a widower, died several years ago in Texas, leaving two children, both of whom are over the age of 19 years. They are as follows:
