Know All Men by These Presents: That in consideration of **Two hundred thirty nine thousand nine hundred and no/100 (\$239,900.00)** to the undersigned grantor, a limited liability company, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **RSR Development, LLC** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **John R. Mineral and mining rights excepted


Subject to existing easements, restrictions, set-back lines, right of way, limitations, if any of record.
