GENERAL WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS: That for and in consideration Ten Dollars (\$10.00) and other good and valuable consideration to the undersigned grantor HOWARD LAKE PROPERTIES LLC, an Alabama limited liability company ("Grantor"), in hand paid by PATRICIA A. HOWARD, a married woman ("Grantee"), the receipt and sufficiency whereof are hereby acknowledged, Grantor does hereby grant, bargain, sell, and convey unto Grantee that certain parcel of real estate situated in Shelby County, Alabama, being more particularly described as follows:

Commence at the Northwest corner of the Northeast Quarter of the Northwest Quarter of Section 29, Township 18 South, Range 2 East, Shelby County, Alabama; thence run North 75 degrees, 44 minutes, 38 seconds West, 2490.48 feet; thence South 30 degrees, 06 minutes, 00 seconds West, 323.00 feet; thence South 74 degrees, 33 minutes, 57 seconds East, 2671.07 feet; thence North 00 degrees, 09 minutes, 21 seconds East, 377.00 feet to the point of beginning. Constituting approximately 20.03 acres.

Together with rights of ingress, egress, and utilities for the benefit of the Property created and existing that certain Declaration of Easements for Ingress, Egress, and Utilities, dated of even date herewith, from the Grantor, as the declarant thereunder, which is recorded contemporaneously herewith in the Office of the Judge of Probate of Shelby County, Alabama (the "Probate Office").


Subject, however, to the following:

- 3. Terms and conditions of that certain Declaration of Easements for Ingress, Egress, and Utilities, dated of even date herewith, from the Grantor, as the declarant thereunder, which is recorded contemporaneously herewith in the Probate Office;
- 4. Long Term Ground Lease from Grantor in favor of Pioneer Lake Residential Association, Inc., an Alabama nonprofit corporation, with respect to the "Island" which is situated on

- Right of Way to Central of Georgia Railroad Company, and as shown on survey of James A. Riggins, Reg. No. 9428, dated March 7, 1999;
- 7. Riparian rights and rights of others to the use of Hurricane Creek and Pioneer Lake; and
- 8. Title to all minerals within and underlying the premises, together with all mining rights and other rights, privileges, and immunities relating thereto, including rights set out in Deed Book 121, Page 294 and Deed Book 355, Page 694 in the Probate Office.

TO HAVE AND TO HOLD unto the said Grantee, her heirs, administrators, successors and assigns forever, together with every contingent remainder and right of reversion. Grantor does hereby covenant with the said Grantee, her heirs, administrators, executors, successors and assigns, that Grantor is lawfully seized in fee simple of the Property; that the Property is free from all encumbrances, unless otherwise noted above; that Grantor has a good right to sell and convey the same as aforesaid; that Grantor will and its successors and assigns shall warrant and defend the same to the said Grantee, her heirs, administrators, executors, successors and assigns forever, against the lawful claims of all persons.

And Grantee, by her acceptance hereof, hereby assumes the obligations of the Grantor as the "Landlord" under the Island Lease arising from and after the date hereof, but only with respect to that portion of the Island(s) described therein which is/are situated within the boundary lines of the Property conveyed to the Grantee hereby.


