The undersigned adopt the following Articles of Organization for the purpose of forming a limited liability company under the provisions of Act No. 93-724 of the 1993 Alabama Legislature and known as the Alabama Limited Liability Company Act (the "Act"):

**ARTICLE I
NAME**

The name of the limited liability company, referred to in these Articles as "Company", is **"BFS PROPERTIES"**

**ARTICLE II
DURATION**

The period of duration of the Company is twenty-five years beginning on the date these Articles of Organization are dated at the end hereof unless sooner dissolved.

**ARTICLE III
PURPOSE**

The purposes for which the Company is organized for the purpose of providing dental care and to conduct such other lawful business for which limited liability companies may be organized under the Act as may be specifically authorized by the members.

**ARTICLE IV
REGISTERED AGENT AND OFFICE**

The Company shall be liquidated and dissolved if an event of dissociation terminates the continued membership of a member in the Company. The Company shall also be dissolved at any time upon the action of the members.

**ARTICLE VII
MISCELLANEOUS MATTERS**

The Company shall have all of the powers of a limited liability company that are set out in the Act. The member has executed an operating agreement which shall govern the operation of the Company.

The Company shall be treated as a partnership for purposes of federal and state income tax purposes and for other State of Alabama Department of Revenue applications.
