DURABLE POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, which are intended to constitute a Durable and Specific Power of Attorney, that I, SANDRA HARRIS, being over nineteen years of age, do hereby appoint REBECCA GRAVES, as my Attorney-in-Fact, for me and in my name, place and stead, and on my behalf and for my use and benefit, to do, perform and execute any and every act that I may legally do through an Attorney-in-Fact limited to the following specific acts:

(1) Make, do and perform all and every act and thing necessary and to execute the mortgage, fixed rate note, truth in lending disclosure, settlement statement and any and all other papers required to be signed by me for the purchase loan transaction for the sales contract price of \$239,900.00 on April 15, 2005 with first mortgage financing by HOMECOMINGS FINANCIAL NETWORK in the gross amount of \$191,920.00, with an interest rate of 5.875% and payable in 360 payments at \$1,135.28 per month, the first payment beginning on June 1, 2005 and last payment on May 1, 2035. (5) Third parties may rely upon the representations of my Attorney-in-Fact as to all matters relating to any power granted to my Attorney-in-Fact and no person who may act in reliance upon the representations of my Attorney-in-fact, or the authority granted to my Attorney-in-Fact, shall incur any liability to me or my estate as a result of permitting my Attorney-in-fact to exercise any power.
