

CORPORATION FORM WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

KNOW ALL MEN BY THESE PRESENTS,

That in consideration of NINETY TWO THOUSAND SEVEN HUNDRED EIGHTY & NO/100---- (\$92,780.00) DOLLARS to the undersigned grantor, Strain Homes, Inc. a corporation, (herein referred to as the GRANTOR), in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell and convey unto Michael D. Lorren and wife, Loretta H. Lorren (herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and and right of reversion, the following described real estate, situated in Shelby County, Alabama:

Lot 28, Block 1, according to the survey of Plantation South, Third Sector, Phase II, as recorded in Map Book 13, Page 89, in the Office of the Judge of Probate of Shelby County, Alabama. Mineral and mining rights excepted.
