KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of Two Hundred Fifty-Six Thousand One Hundred and 00/100 (\$256,100.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR, **Sweeney Homebuilders, Inc., a corporation** (hereinafter referred to as GRANTOR), the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEES, **Troy Carson and Nicole Carson, husband and wife**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit:

Parcel I:

Lot 4, according to the Survey of Lake Ridge, as recorded in Map Book 33, Page 43, in the Probate Office of Shelby County, Alabama.

Subject to existing easements, current taxes, restrictions and covenants, set-back lines and rights of way, if any, of record.


\$248,417.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.



Parcel II:

This easement is to grant ingress and egress along an easement described as follows:
