





HELENA BOARD OF ADJUSTMENTS NOVEMBER 9, 2004

The Helena Board of Adjustments met in a called meeting on Tuesday, November 9, 2004 at 10:00 A.M. in the Council Chambers of the Helena Municipal Building, regular place for holding said meetings.

Present: ----- Dennis Yawn, Chairman

Members: ----- Jerry Owensby, Bill Winford, Chris Williams (newly appointed)

Absent: ---- None

Visitors: ---- Rodney Denman, Gary Thompson, George Pickle, Chad Campbell

The meeting was called to order and opened for business at 10:01 A.M.

Motion was made by Jerry Owensby and seconded by Bill Winford to accept the minutes as written from the last meeting (9-21-04) and an unanimous voice vote was recorded..

The first item on the agenda was a variance request from Denman Builders, Inc. for Lot 28 Falliston Ridge, Second Sector to change the minimum front set back line from 40' to 35' due to the topography of the lot.

There were no objections from adjoining property owners, except from Mr. Wilson on Lot 53, and he asked that they not remove any more trees. Mr. Denman stated that he has a purchaser and the gentleman wants to keep all the trees he can.

Motion was made by Bill Winford and seconded by Chris Williams to grant the request to change the minimum front set back line from 40' to 35' for Lot 28 Falliston Ridge, Second Sector and an unanimous voice vote was recorded.

The next item was Laurel Lakes, LLC asking for a 10' variance on the front set back due to the flood plain location. Mr. Thompson stated that he has a purchaser for this lot and he has a certain house plan that he wants built.

Mr. Pickle stated that they will have to have a flood certificate for this lot. He also asked that if they granted this request that they address landscaping in the front area to help offset the appearance of the house (the road is straight through this area).

Motion was made by Chris Williams and seconded by Bill Winford to grant the variance of 10' on the front set back with the stipulation that they do landscaping as requested by the building official for lot 213 Laurel Lakes - Phase 1, Sector 2 and the following votes were cast:
