FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 23rd day of July 2002, Dudley Elizabeth Crocker and Shay A. Crocker, wife and husband, executed that certain mortgage on real property hereinafter described to Omni Financial Services, LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20020729000349980, said mortgage having subsequently been transferred and assigned to JP Morgan Chase Bank, as Trustee, c/o Residential Funding Corporation, by instrument recorded in Instrument Number 20030915000620150, in the aforesaid Probate Office; and

WHEREAS, on April 19, 2005, the day on which the foreclosure was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly conducted, and JP Morgan Chase Bank, as Trustee did offer for sale and sell at public outcry in front of the Courthouse door in Columbiana, Shelby County, Alabama, the property hereinafter described; and


