TERMINATION OF AGREEMENT REGARDING MAINTENANCE OF UNENCUMBERED OWNERSHIP OF PROPERTY

LEGAL DESCRIPTION

Begin at the Northwest corner of the SE X of the NE X of Section 27, Township 20 South, Range 3 West, run thence in an Easterly direction along the North line of said X - X section for a distance of 1,115.11 feet to a point on the Northwesterly right of way of Shelby County Road 95; thence turn an angle to the right of 97°20' and run in a Southwesterly direction along the Northwesterly right of way line of said Shelby County Road 95 for a distance of 240.24 feet; thence turn an angle to the right of \$2°40' and run in a Westerly direction for a distance of 1,078.61 feet to a point on the West line of the SE X of the NE X of Section 27, Township 20 South, Range 3 West, thence turn ar angle to the right of 88°35'49" and run in a Mortherly direction along the West line of said X - X section for a distance of 238.35 feet to the point of beginning.

ALSO:

Commence at the Morthwest corner of the Southeast % of the Northeast % of Section 27, Township 20 South, Range 3 West; run thence in a Southerly direction along the West line of said % - % section for a distance of 238.35 feet to the point of beginning; from the point of beginning thus obtained, thence continue along last described course for a distance of 163.49 feet; thence turn an angle to the left of 88°35'49° and rur in an Easterly direction for a distance of 1053.57 feet to a point on the Northwesterly right of way line of Shelby County Road No. 95; thence turn an angle to the left of 82°40' and run in a Northeasterly direction along the Northwesterly line of said Shelby County Road No. 95 for a distance of 164.79 feet; thence turn an angle to the left of 97°20' and run in a Westerly direction for a distance of 1,078.61 feet to the point of beginning.
