KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of One Hundred Seventy-Two Thousand Five Hundred and 00/100 (\$172,500.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS, **John Derell Reaves and Charlene K. Reaves, husband and wife** (hereinafter referred to as GRANTORS), the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEEES, **Abbott G. Davis and Sherrie H. Davis, husband and wife**, (hereinafter referred to as GRANTEEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit:

Lot 35, according to the Survey of Cedar Grove at Sterling Gate, Sector 2, Phase 2, as recorded in Map Book 25 Page 53, in the Probate Office of Shelby County, Alabama Mineral and mining rights excepted.

Subject to existing easements, current taxes, restrictions and covenants, set-back lines and rights of way, if any, of record.


\$163,850.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.
