CONSENT AND WAIVER

THIS CONSENT AND WAIVER (this "Consent"), made by BP Products North America Inc., a Maryland corporation ("BP"), successor to and survivor by merger with BP Exploration & Oil, Inc., dated this 2 % day of February, 2005.

WITNESSETH THAT:

WHEREAS, by Limited Warranty Deed dated December 29, 2000, recorded as Document No. 2001-02850, in the Office of the Probate Judge of Shelby County, Alabama (hereinafter referred to as the "Deed"), BP Exploration & Oil, Inc., an Ohio corporation, sold and conveyed to Spectrum Realty, Inc., a Georgia corporation ("Spectrum") a tract or parcel of land that includes that certain tract or parcel of land described on Exhibit "A", attached hereto and made a part hereof (the "Property"); and

WHEREAS, the Deed contains a right of first refusal (the "Refusal Option"), and certain use and operating restrictions (hereinafter referred to as the Use and Operating Restrictions"), including a restriction against using the Property for, among other things, a car wash (said restriction against the use of the Property for a car wash is hereinafter referred to as the "Restriction"); and

WHEREAS, Spectrum has sold the Property to DLR Associates, LLC, a Georgia limited liability company ("DLR"), after Spectrum having given BP the proper notice of Spectrum's intent to sell the Property to DLR in accordance with the terms of the Refusal Option; and

WHEREAS, to induce DLR to purchase the Property from Spectrum, DLR required Spectrum to obtain this Consent from BP;

NOW, THEREFORE, for and in consideration of \$1.00 and other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, BP hereby executes and delivers this Consent under the following terms and conditions:

1.

BP acknowledges that it has elected not to exercise its right of first refusal under the Refusal Option in connection with, AND ONLY IN CONNECTION WITH, Spectrum's sale of the Property to DLR. As provided in the Refusal Option, BP's failure to exercise the Refusal Option in connection with the sale by Spectrum to DLR shall not constitute a waiver of BP's right to exercise the Refusal Option from and after the date hereof with respect to any future sales of the Property within the Refusal Term (as defined in the Refusal Option).





BP consents to the use of the Property for a car wash business, and the Restriction, with respect to such specific use of the Property, AND ONLY FOR SUCH SPECIFIC USE, is hereby waived. The waiver of the Restriction as set forth hereinabove shall not be deemed a waiver of BP's right to enforce the Use and Operating Restrictions with respect to any other use of the Property during the term of the Use and Operating Restrictions as provided in the Deed.

This Agreement shall be binding upon and inure to the benefit of BP and DLR, and their respective successors, successors in title, tenants, subtenants and assigns.
