Know All Men by These Presents: That in consideration of **One hundred forty nine** thousand seven hundred fifty and no/100 (\$149,750.00) to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Joe D. Canada**, an unmarried man (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Vito Amato and Pamela Amato** (herein referred to as grantee, whether one or more), the following described real estate, situated in **Shelby** County, Alabama, to-wit:
