MORTGAGE FORECLOSURE DEED

KNOW ALL PERSONS BY THESE PRESENTS: That KIM L. MARCUS and husband, MICHAEL D. MARCUS, did, on to-wit, DECEMBER 15, 2000, execute a mortgage to CONSECO FINANCE CORP. - ALABAMA, which mortgage is recorded in BOOK 2000, PAGE 44394, in the Office of the Judge of Probate of SHELBY County, Alabama, and

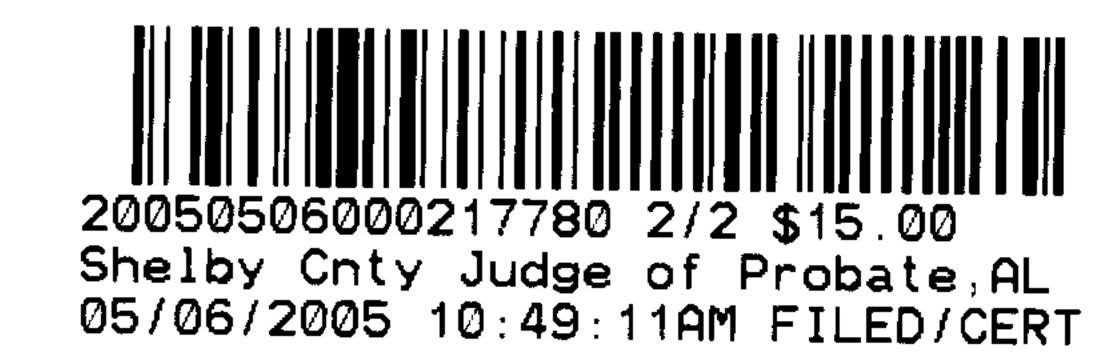
