FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 25th day of January, 2001, Alice T. Dobbs, an unmarried woman, executed that certain mortgage on real property hereinafter described to Bank of Alabama, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. #2001-03888, said mortgage having subsequently been transferred and assigned to Bank One, National Association, as Trustee, by instrument recorded in Inst. # 2002-01924, in the aforesaid Probate Office; and

said mortgage by publication in the Shelby County Reporter, a newspaper of general circulation published in Shelby County, Alabama, in its issues of March 30, 2005, April 6, 2005, and April 13, 2005; and

WHEREAS, on April 26, 2005, the day on which the foreclosure was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly conducted, and Bank One, National Association, as Trustee did offer for sale and sell at public outcry in front of the Courthouse door in Columbiana, Shelby County, Alabama, the property hereinafter described; and

WHEREAS, Michael Corvin was the auctioneer who conducted said foreclosure sale and was the person conducting the sale for the said Bank One, National Association, as Trustee; and


