This Agreement is made this 04/15/2005 , 2005 by and between Quicken Loans Inc., whose address is 20555 Victor Parkway, Livonia, Michigan 48152, Mortgage Electronic Registration Systems, Inc., ("MERS") as nominee for Quicken Loans Inc., whose address is P.O. Box 2026, Flint, Michigan 48501, (collectively referred to as "Quicken Loans") The Bank, whose address is 17 North 20th Street, Birmingham, AL 35203 (the "Lienholder").
