

PARTIAL RELEASE

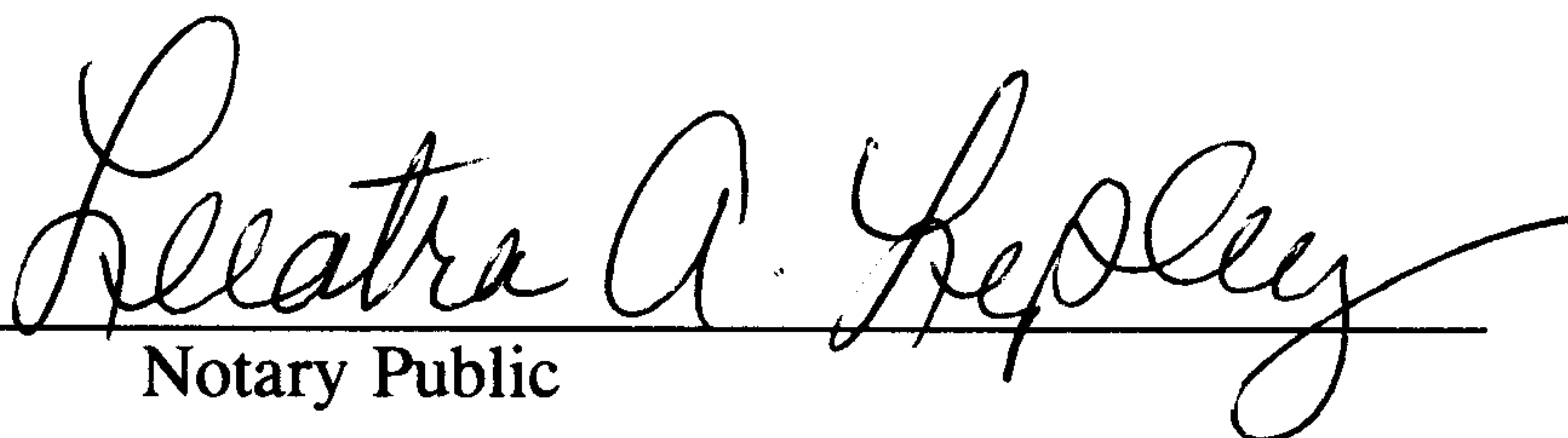
