FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 2nd day of November, 2001, Luther Scott Ray and Eundra Angel Ray, Husband and Wife, executed that certain mortgage on real property hereinafter described to Mortgage Financial Corp., an Alabama corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 2001-51466, said mortgage having subsequently been transferred and assigned to Mortgage Electronic Registration Systems, Inc., as nominee for U. 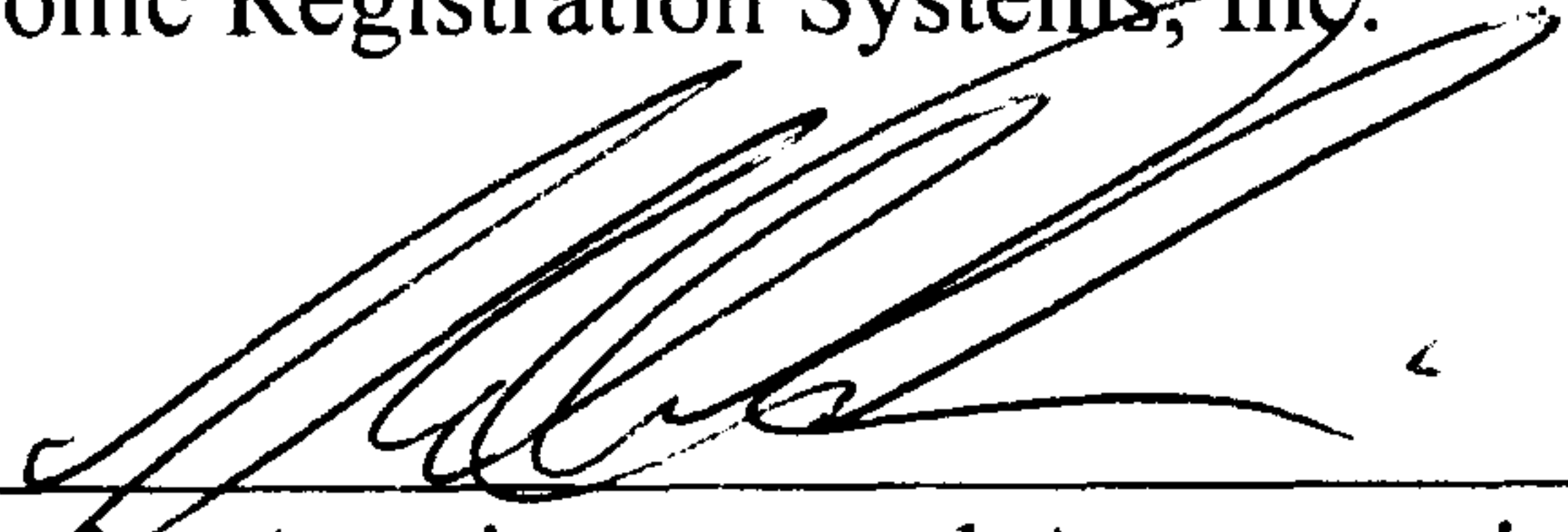

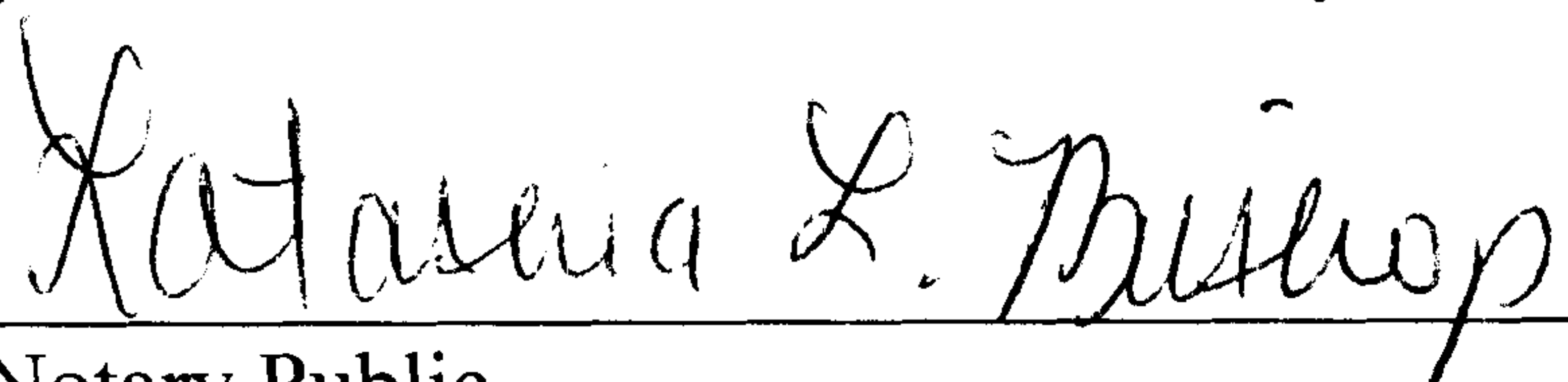
