

A part of Lot 1, W. A. Jones Subdivision, as recorded in the Office of the Judge of Probate, Shelby County, Alabama, more particularly described as follows:  
Commence at a 1" open pipe found at the southeast corner of the NW 1/4 of Section 36, Township 19 South, Range 3 West; thence run South 88 deg. 11 min. 45 sec. West for a distance of 130.02 feet to an iron pin found on the Easterly right of way line of State Highway #261 (Helena Road 80' ROW); thence North 09 deg. 52 min. 14 sec. East for a distance of 175.40 feet to an iron pin found at the Northwest corner of Lot 2, W. A. Jones Subdivision; thence continue along the last described course for a distance of 46.15 feet to an iron pin set and being the point of beginning of said parcel; thence continue along the last described course a distance of 33.08 feet to the point of a curve to the right, said curve having a radius of 241.24 feet and a central angle of 09 deg. 42 min. 25 sec.; thence along the arc of said curve and along the Easterly right of way line of State Highway #261 a distance of 241.24 feet, said arc being subtended by a chord which bears North 14 deg. 43 min. 27 sec.
