

LOAN MODIFICATION AGREEMENT

This agreement is by and between AmSouth Bank ("Bank") and Jimmie Parker Ct stem Homes, Inc. ("Borrower").

WHEREAS, Borrower is indebted to Bank on a ("Loan"), as evidenced by a Promissory Note and Mortgage, dated February 10, 2005 said mortgage recorded in Instrumer t #20050214000071290, in the Probate Office of Shelby County, Alabama.

WHEREAS, Borrower and Bank desire to modify the terms of said loan as set for h here. NOW THEREFORE, for and in consideration of the premises, Borrower and Ban: agree that the terms of the Loan are modified as follows:

The loan amount \$472,000 shall be increased to \$495,000 representing an increase in the loan of \$23,000 applicable only to Lot 15, Deer Ridge Lakes Sector 2. This additional \$23,000 shall be disbursed by the "Bank" as add tional funds are required by the "Borrower" for the construction of the reference i home. If all funds are not required, the balance shall be applied to the note referenced herein. All other terms, conditions and collateral of the note herein referenced shall be made a part of this modification agreement and control the repayment terms thereof.

Except as modified herein, all of the terms and conditions of the Loan, the Note and Mostgage and any and all other instruments executed in connection with said Loan shall remain in full force and effect.


