- 1. The name of the corporation is Performance Plumbing & Gas, Inc.**
- 2. The period of duration is perpetual.**
- 3. The purpose or purposes for which the corporation is organized are the transaction of any and all lawful business for which the corporation may be incorporated under the Alabama Business Corporation Act.**
- 4. The aggregate number of shares of capital stock which the corporation shall have authority to issue is 1,000 shares of common stock.**
