

## ARTICLES OF ORGANIZATION OF G & S, LLC

- 2. <u>PERIOD OF DURATION</u>. The period of duration of the Company shall be perpetual.

The Company has been organized for the purpose of buying, selling, importing, exporting, storing, warehousing, distributing, processing, marketing, and/or the trade in or dealing in and with, at wholesale and retail, and in every other manner truck supplies and/or accessories and materials of every kind and character, including, but not limited to sprayed in bed liners, and all equipment, goods, and materials of every kind and character used in the construction, building, repair, alteration and maintenance of said truck supplies and/or accessories of every kind and character.

The Company has been organized to engage in the to buy, sell, and hold real and personal property in any state or territory necessary for the proper conduct of its business and to do such other things and have such other and further powers as are necessary and incidental to carrying out the general manufacturing business of the Company.

The Company may also transact any other lawful business for which a limited liability company may be formed under the Act, but nothing contained herein shall be construed as authorizing the Company to carry on the business of banking or insurance or to act as a trust company. Furthermore, nothing contained herein shall be construed as authorizing the Company to act as a securities broker, a securities dealer or as an investment advisor.
