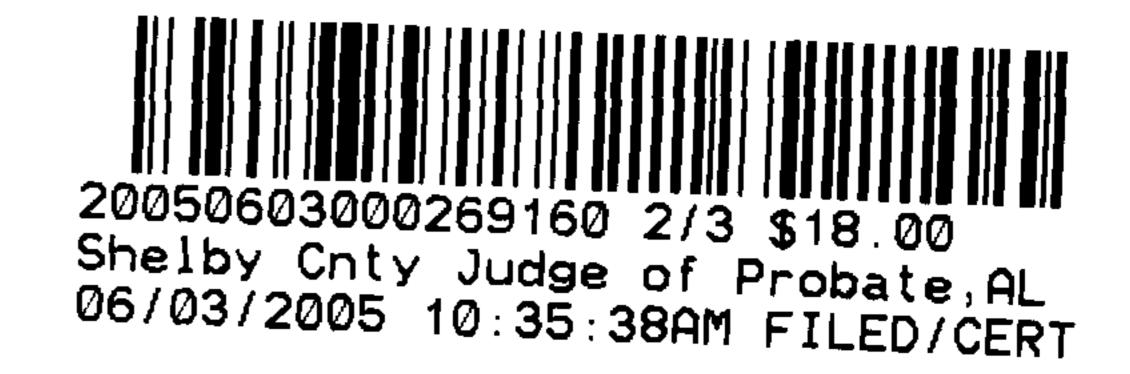
## FORECLOSURE DEED

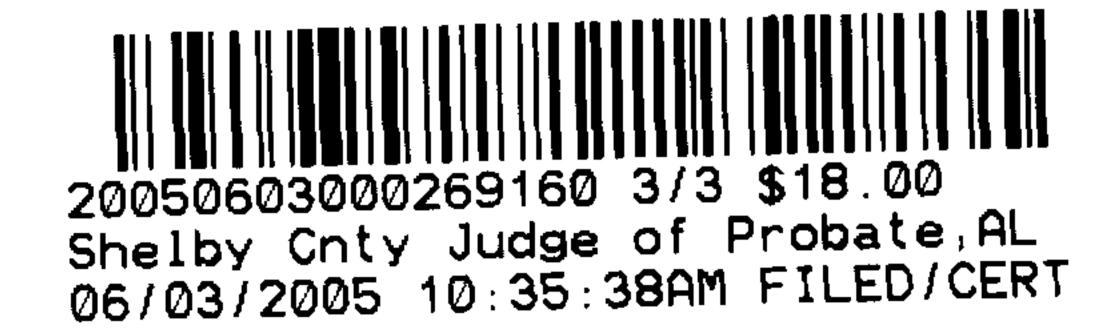
