KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 16th day of November, 2001, Sheryl Moody, a single woman and David L. Moss, a single man, executed that certain mortgage on real property hereinafter described to Hometown Mortgage Services, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument # 2001-57173, said mortgage having subsequently been transferred and assigned to Countrywide Home Loans, Inc., by instrument recorded in Instrument # 20020806000367880, in the aforesaid Probate Office; and

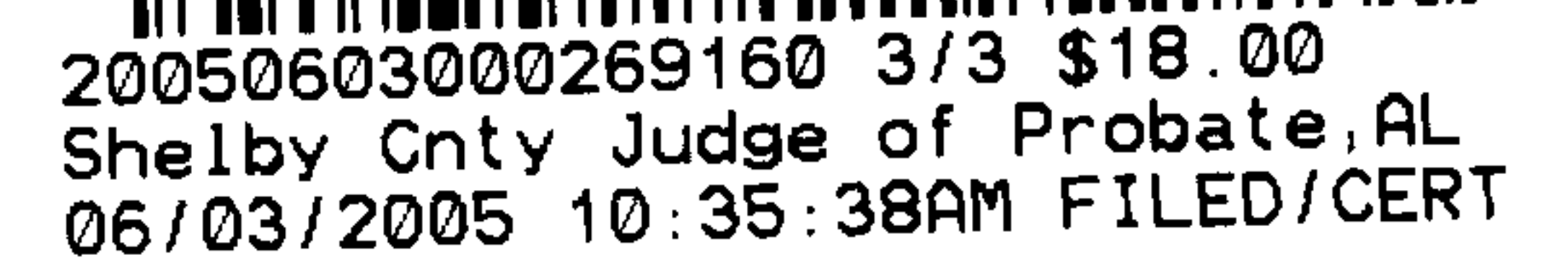
